Colleague Optimization, Process/SOP Documentation & Staff Augmentation, RFP 24-017

Q1: Could you provide a high-level roadmap or the expected milestones for the KCKCC Colleague project so that we are able to address the alignment of the optimization project to the overall KCKCC Colleague Program?

A1: Ellucian will begin in January of 2025 to review all customized code and prepare the college to configure their test environment in the cloud and commence testing and needed training. The cutover to the cloud hosted environment is planned for late June of 2026 at the latest, or sooner if practical. Efforts related to the RFP should begin ASAP in 2025 and remain ahead of Ellucian's planned direct work with functional teams in Q2 and Q3 of 2025. Ellucian is currently planning their scheduled involvement with each of our functional teams using our known blackout dates. Once this schedule is made available to the college it will be shared freely with engaged vendors - or with potential vendors if it is provided to the college prior to 12/20/24.
