## Two KCK Natives Honored at Women's Equality Day Event



KCKCC celebrated Women's Equality Day Aug. 23 where two KCK icons were recognized - former KCK Mayor and lifelong educator Carol Marinovich and Kansas State Rep. Kathy Wolfe Moore.

Women's Equality Day commemorates the granting of women the right to vote in the United States. First proposed in 1878, women known as suffragettes worked peacefully for more than 70 years to gain

equal voting rights. Some would try to pass suffrage acts in individual states. Others organized parades, vigils or even hunger strikes. After President Woodrow Wilson changed his position and started supporting a woman's right to vote, other politicians soon followed his lead. On Aug. 26, 1920, the 19<sup>th</sup> Amendment to the United States Constitution was certified as law, and since 1972, every president has issued a proclamation for Women's Equality Day.

KCKCC's Women's Equality Day event was co-hosted by Women & Gender Advocacy, the Counseling & Advocacy Center, the American Association of University Women, the AAUW Student Chapter and the Intercultural Center.

## Demanding Schedule Foils KCKCC Volleyball in Oklahoma

Not only can KCKCC boast one of the toughest volleyball schedules in NJCAA Division II, the Blue Devils take on the nation's most demanding opening schedule.

Off to a 3-1 start in western Illinois last weekend that included upsets of No. 4 Parkland and No. 17 Illinois Central, the Blue Devils played in Miami, Okla., Monday where they dropped a 3-1 decision to Southeastern Oklahoma A&M.



And now it's back to the shores of the Mississippi River in West Burlington, Iowa, Friday and Saturday for four matches in the Southeastern Community College Invitational. KCKCC will take on North Iowa Area and Hawkeye community colleges Friday at 4 and 6 p.m. and then meet St. Ambrose at 8 a.m. and host Southeastern at 10 a.m. on Saturday.

On the road at Cloud County Sept. 4 and Coffeyville Sept. 9, KCKCC finally returns for its home opener against Johnson County Wednesday, Sept. 11.

The Blue Devils opened with a 25-17 win at Southeastern Oklahoma Monday only to wear down, losing the next three sets 25-21, 21-18, 25-9.

Freshman Cassidy Crist of DeSoto led offensively with 11 kills while Wichita Northwest Tara Mattingly had 10 with 14 digs. Sophomores Malaysia StClair of Beaumont, Tex., added five kills and Gracie Golay of Wichita Trinity Academy and Holton's Lauren Leavendusky four each. Golay also had 26 assists and 11 digs. Sophomore Natalia Vega Apointe of Bayamon, Puerto Rico, again led in digs with 19.



## **Unbeaten Crowder Rallies Past Blue Devils 4-2**

Unbeaten Crowder rallied in the second half to hand KCKCC its first soccer loss of the season 4-2 Wednesday night.

The loss dropped the Blue Devils to 0-1-1 heading into a home clash Sunday with Iowa Central at 2 p.m. The game will follow a noon kickoff between KCKCC and Iowa Central's women's teams.

KCKCC held a 2-1 halftime lead





Roughriders (2-0) take advantage of two fouls to tie the game and then go ahead. The go ahead goal came on a free kick that was deflected once or twice crossing the goal.

Crowder took a 1-0 lead 14 minutes into the game but sophomore Leonardo Bonelli took a pass from Marcos Cabral and drove a kick behind goalkeeper Anthony Garcia while falling to the turf for the tying goal with 28 minutes into the half. Three minutes later, sophomore Marcus Kawah rifled a go-ahead goal past Garcia from 20 yards out. The spectacular goal came on an assist from freshman Javier Blanco.

Freshman goalkeeper Bosco Pery was credited with three saves on shots on goal while Garcia had two for the Roughriders, who controlled the contest much of the way.

And be on the lookout for special giveaways throughout the summer at select baseball games!






