COURSE DESCRIPTION: Students will gain the ability to safely work with shop equipment commonly found in a diesel service and repair facilities. Emphasis on using, maintaining and servicing shop equipment such as hoists, lifts, safety stands, cranes, presses, and grinders. The location and usage of personal protective equipment (PPE) and of common hand tools is included.

METHOD OF INSTRUCTION: A variety of instructional methods may be used depending on content area. These include but are not limited to lecture, multimedia, cooperative/collaborative learning, labs and demonstrations, projects and presentations, speeches, debates, and panels, conferencing, performances, and learning experiences outside the classroom. Methodology will be selected to best meet student needs.

COURSE OUTLINE:

- I. Shop and Personal Safety
 - A. Identify general shop safety rules and procedures.
 - B. Identify and use proper placement of floor jacks and stands.
 - C. Identify and use proper procedures for safe lift operation.

- D. Utilize proper ventilation procedures for working within the lab/shop area.
- E. Identify marked safety areas.
- F. Identify the location/type of fire extinguishers and other fire safety equipment.
- G. Demonstrate knowledge of the procedures for using fire safety equipment.
- H. Identify the location and use of eye wash stations.
- I. Identify the location of posted evacuation routes.
- J. Comply with required use of safety equipment during lab/shop activities.
- H. Identify and wear appropriate clothing for lab/shop activities.
- I. Secure hair and jewelry for lab/shop activities.
- J. Locate and demonstrate knowledge of material safety data sheets (MSDS).

II. Tools and Equipment

- A. Identify tools and their usage in automotive applications.
- B. Demonstrate proper cleaning, storage and maintenance of tools and equipment.
