COURSE DESCRIPTION

This is a study of individual and co-occurring disorders which shall include the study of the symptoms of mental health and other disorders prevalent in individuals. A particular focus will be on individuals with substance use disorders. Screening and assessment tools used to detect and evaluate the presence and severity of co-occurring disorders will be examined as well as the evidence-based strategies for managing risks associated with treating individuals who have individual and co-occurring disorders.

This course will also focus on the nature and types of mental/psychological disorders commonly encountered by behavioral health professionals. Specific disorders to be considered are: substance-related and addictive disorders, schizophrenia spectrum and other psychotic disorders, mood disorders, anxiety disorders, trauma-related disorders, neurocognitive disorders, personality disorders, eating disorders, dissociative disorders, and ethical/legal considerations.

COURSE OUTCOMES:

- 1. Students will demonstrate comprehension of rudimentary knowledge of the nature, characteristics, symptoms, etiology and treatment of the primary mental disorders, as defined by the current diagnostic manual.
- Students will apply, through case studies, the primary diagnostic criteria, as defined by the current diagnostic manual, and best practice treatment recommendations associated with anxiety, mood, psychotic, somatic, personality, dissociative, stress related, neurodevelopmental and substance use disorders.
- 3. Students will summarize and explain the symptoms, current evidence based evaluation and treatment of mental health disorders and substance use disorders when a co-occurring diagnosis is present.
- 4. The student will employ, though case studies, best practices involving culturally informed treatment, ethical responsibility, scope of practice, clinical documentation, and client rights.
