Board of Trustees Meeting

September 20, 2011

The regular monthly meeting of the Board of Trustees was called to order at 4:00 p.m. in the Board Conference Room at the College by Trustee Ray Daniels. Roll call indicated the following Trustees present: Cathy Breidenthal, Ray Daniels, Wendell Maddox, J.D. Rios, and Clyde Townsend. Trustees Donald Ash and Mary Ann Flunder were not present at this time.

Trustee Townsend seconded and the motion carried.

- 2. Trustee Townsend moved to approve the minutes of the Regular Meeting & Annual Budget Hearing of the Board of Trustees on August 9, 2011. Trustee Breidenthal seconded and the motion carried.
- 3. Trustee Townsend moved to approve the minutes of the Special Meeting of the Board of Trustees on August 31, 2011. Trustee Rios seconded and the motion carried.
- 4. There were no Patrons or Petitioners wishing to address the Board.
- 5. Under communications, Dr. Givens read a letter from the organization Maryland Online.org commending Staff Member Becky Giger on the work she had done with them in serving on a countrywide committee whose purpose it was to review and revise the Rubric for Higher Education of the Quality Matters Program. The Board applauded Ms. Giger's work.
- Under the President's Report, Dr. Givens introduced Dr. Cindy Lane, Superintendent of USD 500. Dr. Lane spoke briefly on the upcoming changes to the district's assessment program. Following discussion the Board thanked Dr. Lane for her presentation.
- 7. Under the Provost's Report, Dr. Agha-Jaffar noted that line 21B had been left off of the table and handed out that correction of the Master Contract for 2011-2012. She stated that the Faculty Association had ratified the Master Contract for 2011-2012 with this correction, and introduced Jerry Pope, the present President of KNEA to say a few words. Mr. Pope spoke briefly on behalf of the Faculty Association by saying that the approval of the contract was by overwhelming majority vote and thanked the Board for their efforts in this negotiation process. Trustee Rios moved that the Board approve the Faculty Contract as ratified by the Faculty Association. Trustee Maddox seconded and the motion carried. The Board Chairman, Dr. Ray Daniels and Faculty Association President, Jerry Pope signed the contract at this time.
- 8. Dr. Agha-Jaffar then introduced Tiffany Bohm, Director of the Physical Therapy Assistant program to say a few words regarding \$50,000 award to the program. Following the presentation, Chairman Daniels commended them on this achievement.

Trustee Mary Ann Flunder arrived at 4:30 p.m.

- 9. Dr. Agha-Jaffar noted that the next item was the report on the "Accelerating Opportunities for Kansans" Grant and introduced Dr. Marvin Hunt, Dean of Continuing Education and Business Division to give that update. The Board thanked him for his work with the grant.
- 10. Dr. Agha-Jaffar then introduced Dr. Sangki Min to give an update on the Strategic Plan. Following Dr. Min's brief presentation, Chairman Daniels asked that Dr. Min report more completely at the October Board meeting.

- 11. In conclusion, Dr. Agha-Jaffar submitted her written report for acceptance. Trustee Townsend moved to accept the written report as presented. Trustee Maddox seconded and the motion carried. (Attachment 1)
- 12. Under the Vice President's Report, Brian Bode gave a brief construction update on the sidewalks, and the public meeting about the athletic field with the architects and the Athletic Dept. set for September 21st at 5:30 p.m. in the Upper Jewell Bldg. Mr. Bode updated the Board on the Fine Arts recommendations for additional construction for Performing Arts Center. The bids were more expensive than expected. Mr. Bode explained that an additional 375-425 square ft. structure to the existing PAC was suggested. If this would be acceptable for consideration, he would need to take bids from specialized builders. Following discussion, it was the consensus of the Board that it be discussed further at the October Board meeting. The Facilities & Finance Committees did review some of this information and wished to move forward with discussion with the full board to see what other alternatives were available along with finance packages.
- Mr. Bode spoke briefly that the TEC 1 and Plaza locations would not be available for occupation until 2013-2014. Trustee Rios moved to approve the written Vice President's Report as submitted in the packet. Trustee Maddox seconded and the motion carried. (Attachment 2)
