- Under the President's Report Dr. Burke reported that Trustee Mary Ann Flunder had received the award of one of KC Business Magazine's Most Influential Woman of 2010. The celebration will be held at the National WWI Museum at the Liberty Memorial on March 11, 2010 at 5:30 p.m. – 7:30 p.m.

- 7. The Assoc. Provost for Academic Services, Dr. Tamara Agha-Jaffar, introduced the Dean of Business & Continuing Education, Dr. Sue Courtney, who in turn introduced Ms. Mary Kobe-Peterson to speak briefly regarding the High Schools & Concurrent Enrollment programs of the college with the local high school. **James Starshak,** Adjunct instructor in Allied Health has been approved as a continuing education provider by both the Kansas Physical Therapy Association and the Arkansas State Board of Physical Therapy. They approved his 8-hour Yang Tai Chi workshop for continuing education. He also spent two weeks in Sydney, Australia, completing the Master Trainer in Tai Chi for Arthritis Program. He will work closely with the Arthritis Foundation to be a "train-the-trainer" for their new Tai Chi for Arthritis instructors. There are only 52 such qualified Master trainers worldwide, with only 20 (including James) in the USA.

**Allyson McNitt**, adjunct in English has had chapter 1 of her thesis accepted for presentation at the Mid-America Medieval Association conference in February. She will be representing KCKCC.

**Elizabeth Banks,** adjunct in Theatre was awarded the Barbizon Award for Theatrical Design Excellence. She will be provided with feedback on her work from professionals in the field, will receive national recognition for her work, and will exhibit her work at the Kennedy Center.

**Wiley Wright,** KCKCC Mortuary Science Coordinator, has been the swimming coach for 25 years at Shawnee Mission East. In honor of his service, the Shawnee Mission East Swimming Pool has been renamed the Wiley Wright Pool. Wiley was honored in a special awards ceremony in January.

**Dr. Mehdi Shariati** has published two articles and a book review in a journal in Iran. **Dr. Mario Ramos-Reyes** will be on a panel presentation at the Bi-annual Conference of the Sela-Yale Law School in June. He will be presenting on the topic of Imprisonment, Ethics, and Human Rights.

His paper on the subject is being published this July by Yale Press.
