The regular monthly meeting of the Board of Trustees was called to order at 8:00 a.m. in the Board Conference Room at the College by Trustee Ray Daniels. - 2. Trustee Maddox moved to approve the minutes of the Special Board of Trustees meeting on March 9, 2011 as presented. Trustee Townsend second and the motion carried.
- 3. Trustee Rios moved to approve the minutes of the regular Board of Trustees meeting on March 15, 2011 as presented. Trustee Breidenthal seconded and the motion carried.
- 4. Trustee Townsend moved to approve the minutes of the Special Board of Trustees meeting on March 30, 2011 as presented. Trustee Ash seconded and the motion carried.
- 5. Trustee Rios moved to approve the minutes of the Special Board of Trustees meeting on March 31, 2011 as presented. Trustee Maddox seconded ad the motion carried.
- 6. The Chairman asked if there were any Patrons or Petitioners wishing to address the Board at this time. Mr. Richard Mabion of 2035 Oakland, Kansas City, KS stood to address the Board and distributed a program from the 2011 "Breaking the Silence" conference held at the college on March 11 & 12. He thanked the Board for the college's partnership in this evet and noted the different sponsors listed on the program who also participated. The Chairman thanked Mr. Mabion for his work in the community.

Ms. Mary Martin of 804 S. 89<sup>th</sup> St., Kansas City, KS stood to address the Board as a citizen of Wyandotte County and also a bidder on a recent project bid. She noted her concerns with the bidding process on this project and wanted to share it with the Board. The Chairman thanked Ms. Martin for addressing the Board and noted that they were glad she had come to the meeting.

  - Governor's Latino Commission meeting on campus on April 28<sup>th</sup>

- The update and revision on the KCKCC catalogue has been completed and submitted for layout,
- On Wednesday, April 13, the Workforce Development committee hosted a panel discussion on Essential Employability Skills (EES). The panel consisted of representatives from UPS, Livestrong Sporting Park, Scientific, Quest Diagnostic, and Thatcher Funeral Home. Of the approx. 275 attending, most were students from both the main campus and the TEC. A video archive of the event will be placed in the KCKCC library and will be shown on Cable channel 17. There is consideration of holding this panel every semester.
- TEC Appliance Repair program: In the Skills USA competition, KCKCC students received top 3 places: Mike Dunn in first with a score of 89% and qualifying for nationals; Dan Ward in 2<sup>nd</sup> place; and Herb Rock in 3<sup>rd</sup> place.
- KCKCC TEC has been providing forklift and OSHA 10 training for Barron's Auxier, a company that provides warehouseman training for FEC and the Kansas Dept. of Corrections. 10 of the 11 students who completed the warehouseman program, are employed in warehouse positions. 3 students in the first group of students sponsored by the Kansas Dept. of Corrections, completing the program, are employed and 4 are in the process of interviews. Two in the second group sponsored by the Dept. of Corrections, have interviews lined up awaiting their completion of the training. Students who complete the training receive OSHA 10 and OSHA Forklift Certificate are the two nationally recognized certificates awarded for training completion. At a very reasonable price, TEC has purchased an upright forklift for training use.
- Cheryl Runnebaum, Assistant Prof. of Professional Cooking, passed all the requirements for the Certified Hospitality Educator Training and will be receiving her certificate.
- We are working on an articulation agreement with JCCC for an AAS in Food and Beverage. Students who receive their cooking certificate from us can take their gen. eds from here and then transfer to JCCC to complete their Associate's degree.
- Mario Ramos-Reyes, assistant professor of Philosophy, has been published in the SELA-YALE Law School Conference 2010. This is the 5<sup>th</sup> volume that includes one of his papers.
- The Kansas Board of Nursing came for a site visit for the P.N. program. Director, Susan White, excelled in writing the self-study and in preparing for the visit. The visitors were very impressed and they had no requirements. Congratulations to Susan and Shirley for a job well done.
- Kansas City Jazz Summit: April 25-30 on KCKCC campus. 24 H.S. and college bands and two jazz choirs from Oklahoma, Missouri and Kansas will be participating as well as members of the Kansas City Jazz Orchestra and other leading jazz educators from the Kansas City area Thursday through Saturday. The summit is

geared towards middle school, high school, and college students and will include clinics, performances, Thursday night's Jazz Cabaret, and Friday evening performances at Unity on the Plaza.

Mechanical later in the meeting. Trustee Rios moved to approve Financial Recommendations items X C.8 - 21 as presented, and table #22 until Mr. Bode receives more information from KC Mechanical later in the meeting. Trustee Townsend seconded and the motion carried.

- 18. Dean Leota Marks presented the updated KCKCC Organizational Chart for approval. Dr. Burke explained that there was no philosophical change, just added clarification of titles and programming alignments. Trustee Rios moved to approve the updated KCKCC Organizational Chart as presented. Trustee Breidenthal seconded and the motion carried.
- 19. Under Committee Reports, Trustee Breidenthal gave a brief activity report of the College Advancement Council.
- 20. Dr. Burke recommended approval to alter the contract of EnGage, LLC to an hourly rate not to exceed \$4,000.00 per month, instead of a flat rate of \$4,000.00 per month. Trustee Rios moved to accept the recommendation as stated. Trustee Townsend seconded and the motion carried.
- 21. Chairman Daniels noted that they would like to schedule a special meeting with the College Senate this year instead of in conjunction with the regularly scheduled board meeting. The consensus was that Trustee Daniels would contact the appropriate college senate officer to set the time and date.
- 22. Chairman Daniels noted that Dr. Burke had selected Sunday, June 12, 2011 for the date of his retirement reception here at the college in the Upper Level Jewell Bldg. A committee of Board members and staff personnel was formed to work on this and report with more detail next month.
- 23. Chairman Daniels stated that after discussion with the Board, it was their consensus to waive Board Policy 2.00 Hiring Policy, page 42 which would require a completed application for the applicants for the position of President. Trustee Rios moved to approve waiver of the Board Policy 2.00 Hiring Policy, page 42 which would require a completed application for the applicants for the position of President. Trustee Townsend seconded and the motion carried.
- 24. The next item of discussion was to set the date and time of the special meeting to discuss the following item #7 previously tabled:
  - Request authority to increase tuition by \$5.00 per credit hour in-state and \$15 per credit hour out-of-state for the 2011/2012 academic year. KCKCC will remain the 5<sup>th</sup> lowest tuition of the 19 Kansas Community Colleges and will be \$10 per hour less expensive than Johnson County and \$16 less than MCC in MO.

Following discussion the consensus was to meet on April 25<sup>th</sup> at 12 Noon.

25. The next item was the information from KC Mechanical regarding their figures for the combined bid for HVAC and Plumbing for TEC 2 and Tec 3. Mr. Bode stated that the

combined bid would be approx. \$28,000.00 more than it would be to keep Mid-States Heating & Cooling as the HVAC awarded bid and KC Mechanical as the Plumbing awarded bid. Following discussion, Dr. Burke recommended entering executive session for a period of 30 minutes to discuss financial matters of private enterprises, consultation with college attorney on matters deemed privileged within the attorney client relationship, a personnel matter subject to attorney-client privilege to the privacy of the individual involved, possible acquisition of real estate, and faculty negotiations, with possible action to follow. Trustee Townsend moved to accept the recommendation to enter executive session as recommended. Trustee Rios seconded and the motion carried. The chairman allowed for a seven minute break before convening in executive session at 10:25 a.m.

- 26. Executive session commenced at 10:25 a.m.
- 27. The Board reconvened in regular session at 10:55 a.m. at which time Chairman read the resolution of the Intent to Non-Renew the Non-Tenured faculty member Phanh Vongphrachanh for the 2011-2012 academic year. Trustee Rios moved to approve the resolution as read. Trustee Townsend seconded and the motion carried. (Attachment 1)
- 28. Trustee Rios moved to approve item #22 to contract with MidStates Heating and Cooling, Inc. for \$205,900 for HVAC work at TEC 2 and TEC 3. Trustee Ash seconded and the motion carried.
- 29. The chairman noted that the Board would probably hold off on review of the Trustee Handbook until the search process was finished.
- 30. Trustee Townsend moved to adjourn the meeting. Trustee Rios seconded and the motion carried.
